Status of Single Scheme Project Activities

The Department of Public Expenditure and Reform has implemented its Business Contingency Plan. For the Single Scheme Project Team, this means that a number of team members are working remotely at this time, while other team members may be deployed to support tasks elsewhere within the Department or wider public service in the near term.

Ongoing requirement to remit Single Scheme contributions

As part of your local contingency arrangements, and to ensure no interruption to the anticipated supply of monies to the Exchequer, you should please ensure that all Single Scheme contributions due continue to be promptly remitted to the designated DPER bank account within the statutory timelines.

Single Scheme Databank

Bodies are being onboarded to the Single Scheme Databank in waves. We are mindful that there may be impacts on the preparation of data files for **Wave 3 and 4** bodies that are presently in the process of onboarding to the Databank. Where organisations are redeploying personnel directly involved in these activities to other tasks, we confirm that there is flexibility with previously notified timelines for the upload of Databank files.

If you are able to safely progress the Databank files while working remotely, we would advocate this approach. We appreciate that you may need to access paper records to close out on some data queries, particularly in relation to historical leavers, before your files can be fully finalised prior to submission.

Should your organisation anticipate significant deviation from previously advised timelines, we would please ask at this time that you endeavour, where possible, to keep us updated by email over the coming weeks.

The Department will be reassessing its onboarding planning for other bodies beyond Wave 4 in the short-to-medium term.
