Annual Survey

We will be sending out a link to the annual survey to all Relevant Authorities in early January 2025 seeking data as at 31 December 2024 on your Single Scheme members. The primary objective of the survey is to obtain total membership numbers in order to accurately calculate Pension Authority fees, for payment by DPENDR, on behalf of all Relevant Authorities. We will take the opportunity to check in on other areas of scheme administration, including data relating to levels of compliance (annual statements etc.). The deadline for receipt will be **24**^h **January 2025** and a return by all Relevant Authorities is mandatory. *An advance draft of all of the questions that will be asked is available on our website <u>here</u> to allow you to make advance preparations.*

Single Scheme Databank

Reminder: <u>1 November 2024</u> was the date fixed by the Minister for organisations to make their return to the Single Scheme Databank for 2023. We would like to thank all those RAs who have completed these returns. For those who have yet to do so, there are **three** Scheme Files required for the return:

- Membership Data
- Benefit Payments Data
- Purchase and Transfer Data

2024 Training Review

The team provided Administration training in Quarters 1, 2 and 4 this year. Each quarter contained 6 modules on the following topics:

- Recruitment and Onboarding
- Leaving Employment Module
- Annual Administration Activities Module
- Retirement Benefits Administration
- Death Benefits Administration
- Purchase and Transfer of Retirement Benefits

We hosted these webinars via Microsoft Teams and had over 1,800 attendees this year. We will commence training in Q1 next year, however we do not have dates organised yet for the next round of webinars.

When we do have dates, an email will be sent around to all Pension Administrators and we will ask for the details of the members they wish to have attend. We will then take note of these details and send out the link. Centralised Administration System

During 2024 the Single Scheme team engaged with a wide range of stakeholders to progress the Centralised Administration System. Work continues apace, and we hope to provide you with more information during 2025. Please keep an eye out for updates in the future bulletins.

State Increase in State Pension (Contributory) Rate Pension

According to the Section 16 of the <u>Social Welfare Act 2024</u>, the maximum State Pension (Contributory) rate will increase on 3 January 2025 from \notin 277.30 to \notin 289.30. Although this is the responsibility of the Department of Social Protection, we are including this notice in the bulletin to allow you to make any systems preparations required for the effects this will have on Single Scheme referable amounts and contributions thresholds.
